
3 ☒ **REMARKS**

The following are the comments/suggestions of the NSCB Technical Staff on the survey:

1. Per clarification with BLES staff and in the reply of BLES to the initial comments of the NSCB-TS, **agriculture, forestry and fishery (AFF) establishments** will be covered in the 2012 OWS. However, it was noted in Item 12.c (Sampling unit) of the SSRCS Form 1 that only non-agricultural establishments employing 20 and over are covered in the survey. Hence, it is suggested that the particular item in the SSRCS Form 1 be revised to indicate the inclusion of AFF in the sample coverage.
2. On the questionnaire, we would like to reiterate our suggestion that in addition to Item B.1 (Basic pay) and Item B.2 (Allowances), an item on **total payment to employees/workers during emergency conditions** be also included. Information generated from this additional data item will aid in the compilation of more comprehensive statistics on social protection, particularly in labor market concerns, which is one of the emerging concerns in the Philippine Development Plan (PDP) for 2011-2016 and the Philippine Statistical Development Program (PSDP) 2011-2017.
3. To maximize the use of collected survey data particularly data items which have male and female disaggregation, we would like to reiterate our previous comment in the 2010 OWS to generate sex-disaggregated tables for the following: **(a) percent distribution of time-rate workers by industry; (b) percent distribution of time-rate workers by occupation; and (c) percent distribution of time-rate workers by region.**
4. We understand that the **technical notes** for the OWS is in the Field Operations Manual (FOM), which is published in the BLES Electronic Archived Microdata System (BEAMS). Likewise, we noted that survey results of the OWS are being published in the LABSTAT Updates. Hence, we suggest that a link to the FOM be included in the LABSTAT Updates articles, which discuss the results of OWS, to allow users to directly access the survey's technical notes.
