The following are the comments/suggestions of the NSCB Technical Staff on the survey:

1. We have noted that part A General Information Item 3 page 3; "Please provide the following information for your establishment" of the 2004 OWS survey was deleted in the 2006 OWS survey. In the OWS 2004, questions regarding "ownership", "multinational", "market", "with union", and "with CBA" were not included in the 2006 OWS. What is the reason for the deletion of this section? Are users not using the data from this section?
2. We observed that the part C items 1 to 3 of the OWS 2004 were deleted in the OWS 2006. Item 1 asked about the hiring or entry rate, item 2 asked about the minimum educational requirement while item 3 asked about the minimum years of related experience of employees. What is the reason for the deletion of this section? May we know if the information provided here is processed, and if so, are users not using the data from this section?
3. Please submit to the NSCB the final documents used for the survey - Questionnaire, Enumerator's Manual, Table formats, etc.
